Sold and installed Poly Fill (foam fill) for commercial use in heavy construction equipment. Processed two manufacturer tire recalls: the Firestone (Ford Explorer) tire and BFG tire recalls of 2000 and 2012. Familiar with the industry *Tire Guide* and various manufacturer tire fitment guides for authorized safe tire sizing substitutions and Plus 1, 2, 3 conversions.
